The following penalties apply only to cruise portion of the trip: From registration date with GAMT to 12 April, 2012 client will lose the \$550pp deposit; from April 12, 2012 to May 2, 2012, penalty will equal 50% of the gross amount of the cruise fare paid; from May 2, 2012 to June 1, 2012 penalty will equal 75% of the gross amount of the cruise fare paid; from June 1, 2012 to June 22, 2012, penalty will equal 100% of the gross amount of the cruise fare paid. Any cancellations after April 12, 2012 will entail a penalty fee of \$150 to cover administrative costs. If RBC cancellation insurance has been purchased, the penalty amount may be claimed according to RBC Insurance practices. Air tickets are subject to the corresponding airline rules for cancellation. *Reservation fare per person is defined as the cost of any cruise or land segment purchased from Garth Allen Marksted Travel.
